The Governor appoints two public school students entering their senior year to serve as non-voting members of the Connecticut State Board of Education for a one-year period. Student Board members participate fully in discussions about education policy and lend an important perspective to Board deliberations. We encourage all eligible students to consider applying for membership on the Board (July 1, 2015, through June 30, 2016).

ARE YOU QUALIFIED?

Students who wish to apply for membership on the Board:

- > Must be enrolled in a public high school; and
- Must have at least a B+ average; and
- Will have completed Grade 11 prior to July 1, 2015; and
- Must be able to attend monthly all-day meetings in Hartford (usually the first Wednesday of each month).

HOW TO APPLY

If you meet all of the above qualifications and wish to apply for membership on the Board, please submit the following: (1) application form; (2) three reference letters from your teachers or school administrators; (3) your resume; and (4) a one-page statement describing what you consider to be the most critical issue(s) in public education today, and why you believe you are qualified to serve on the Board.

SCREENING PROCESS

The State Student Advisory Council on Education will review all application packages. Based on its review, the Council will select applicants for interviews to be conducted in the spring. At the conclusion of the interview phase, the Council will recommend five candidates to the Governor for his consideration. The Governor will interview the five finalists, and appoint two students to the Board for a one-year term commencing July 1, 2015.
